PENDING HEARING CONDITIONS WITH FORMAL SUPERVISION

THIS IS AN AGREEMENT BETWEEN THE JUVENILE OFFICE AND/OR THE
COURT AND THE JUVENILE AND PARENT/GUARDIAN.

1. I will attend school, G.E.D. classes, or work (which ever is appropriate) each day unless excused by my parent/guardian, or Probation Officer. I will also act in a cooperative, responsible manner while in attendance there.
2. I will cooperate fully with my Probation Officer and make all probation contacts as prescribed by that Officer.
3. I will obey all rules and instructions of my parent/guardian.
4. I will obey all Federal and State laws, municipal and county ordinances.
5. I will not associate with anyone of a negative influence as determined by my parent/guardian, Probation Officer and myself.
6. I will not possess or use any controlled substance (drug) or alcohol.
7. I will report any and all violations of my probation immediately to my Probation Officer.
8. I will adhere to curfew time as determined by my Probation Officer/parent.
9. I will notify my Probation Officer immediately of any change of address or phone number.
10. I agree to attend, cooperate with and successfully complete any counseling or treatment program I am referred to.
11. I agree to cooperate with drug and alcohol screening and to submit to random urine sample testing when requested by my Probation Officer.

12. I will satisfactorily complete _____ hours of community service through Court Alternative Sentencing Program (CASP.) I will make prompt contact with CASP at 721 North Main, Springfield, Missouri, and make payment arrangements to being the community service. Payment of the \$40.00 fee is to be provided by the juvenile and/or parent at time of enrollment. Community service will be completed no later than _____.
13. I agree to report for and cooperate with probation sanctions and/or detention periods as assigned by the Probation Officer.
14. I agree to wear and to cooperate with any and all aspects of the house arrest surveillance equipment. I understand that any tampering or damage done to the equipment will be grounds for revocation of my probation and I will be held financially responsible for that damage.

JUVENILE: I know that the Juvenile Officer and/or Court has placed me under supervision because my behavior has been harmful to myself and others. I, therefore, accept this responsibility of helping myself, my family, and my community by meeting the terms listed above.

PARENT/GUARDIAN: I know that the Juvenile/Probation Officer and/or Court can help my son or daughter, only if I also help by doing my best as a parent. I will, therefore, continue this responsibility and agree to do the following:

1. I will cooperate with the Juvenile Officer and Probation Officer and/or Court.
2. I will make every effort to see that my child attends school or G.E.D. classes each day, or maintains employment, if withdrawn from school.
3. I understand that the role of the Juvenile Officer and Probation Officer and/or Court is for assistance only; that I agree to continue my responsibility of parenting my child.
4. I agree to cooperate with the Juvenile Office and Probation Officer by signing authorization for release of requested information.

I fully understand and accept the terms of this agreement.

I HAVE READ THE ABOVE RULES AND UNDERSTAND THE TERMS OF MY PROBATION. I REALIZE THAT A VIOLATION OF THESE RULES MY RESULT IN THE REVOCATION OF MY PROBATION AND AN OUT OF HOME PLACEMENT IN A SECURE DETETION OR STATE RUN FACILITY.
