**CONDITIONAL RELEASE FROM DETENTION**

I, \_\_\_\_\_, knowing that I have a Delinquent Jurisdictional Dispositional/Motion to Modify Previous Order of Disposition hearing scheduled, do agree to the following conditions per my release from the Greene County Juvenile Detention facility pending my hearing at the Greene County Juvenile Court, 1111 North Robberson, Springfield, Missouri.

1. I will report to my Juvenile Officer/Probation Officer as requested until my Delinquent Jurisdictional Dispositional/Motion to Modify Previous Order of Disposition hearing is held and a determination is made regarding my placement or classification.
2. I will remain at home, on House Arrest, unless in the company of my parent(s), or with a responsible adult approved by my parent(s) and by my Juvenile/Probation Officer.
3. I will obey all Federal and State laws, municipal and county ordinances, and I will obey the reasonable instructions of my parent(s).
4. Said juvenile shall report to the Juvenile/Probation Officer as instructed and follow any counseling and groups recommended and required by the Juvenile/Probation Officer.
5. I will attend school, G.E.D. classes, or work (which ever is appropriated) each day unless excused by my parent/guardian, or Juvenile/Probation officer. I will also act in a cooperative, responsible, manner while in attendance there.
6. I will not associate with anyone of a negative influence as determined by my parent/guardian, Juvenile/Probation Officer and myself.
7. I will report any and all violations of my probation immediately to my Juvenile/Probation Officer.
8. I will notify my Juvenile/Probation Officer immediately of any change of address or phone number.
9. I agree to cooperate with drug and alcohol screening and submit to random urine sample testing when requested by my Juvenile/Probation Officer.
10. I agree to report for and cooperate with probation sanctions and/or detention periods as assigned by the Juvenile/Probation Officer.

11. I will cooperate with the Juvenile/Probation Officer and/or Court.

12. I agree to wear and to cooperate with any and all aspects of the house arrest surveillance equipment. I understand that any tampering or damage done to the equipment will be grounds for revocation of my probation and I will be held financially responsible for that damage.

PARENT/GUARDIAN: I know that the Juvenile Office, Juvenile/Probation Officer and/or the Court can help my son or daughter, only if I also help by doing my best as parent. I will, therefore, continue this responsibility and agree to do the following:

1. I will cooperate with the Juvenile Office, Juvenile/Probation officer and/or Court.
2. I will make every effort to see that my child attends school or G.E.D. classes each day or maintains employment, if withdrawn from school
3. I understand that the role of the Juvenile Office and Juvenile/Probation Officer and/or Court is for assistance only; that I agree to continue my responsibility of parenting my child.
4. I agree to cooperate with the Juvenile Office and Juvenile/Probation Officer by signing authorization for release of requested information.
5. I will attend all counseling sessions and therapy groups I am referred to.
6. I understand that I am financially responsible for any lost, stolen, or damaged piece of electronic monitoring system my son/daughter is placed on.

I understand that if I violate one (1) or more of the above conditions, I may be brought back to the Juvenile Detention Facility and held until my scheduled hearing, and a Detention hearing will not be required.
