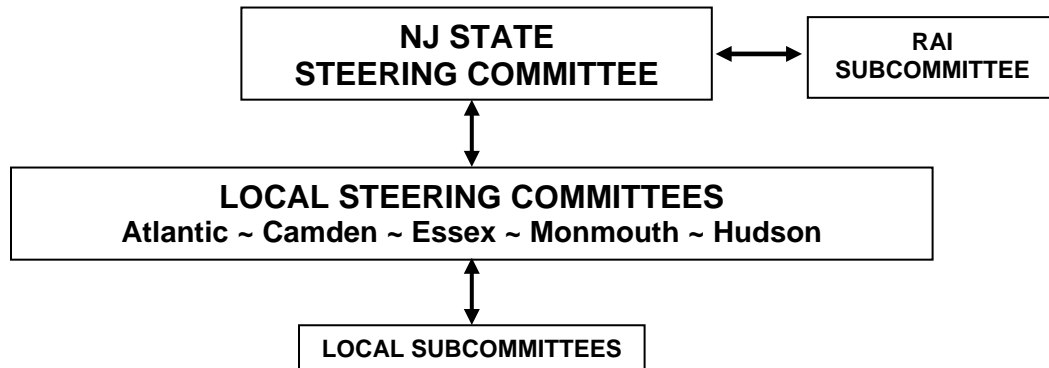


NEW JERSEY JDAI STRUCTURE

As a state JDAI replication site, New Jersey has created an organizational structure that provides leadership from both state and local key actors in the juvenile justice system. This is accomplished through the creation of both state and local steering committees. The State Steering Committee is charged with guiding the overall JDAI process and dealing with crosscutting JDAI issues. Local Steering Committees are charged with operating JDAI in the pilot counties. The Committees share information and are linked by key actors serving at both the state and local level. Additionally, NJ's JDAI is staffed by the NJ Juvenile Justice Commission's Office of Local Programs and Services. A team comprised of a Detention Specialist and Management Representative staffs each pilot county. The entire JJC JDAI team also works together to staff the State Steering Committee and RAI Subcommittee.
