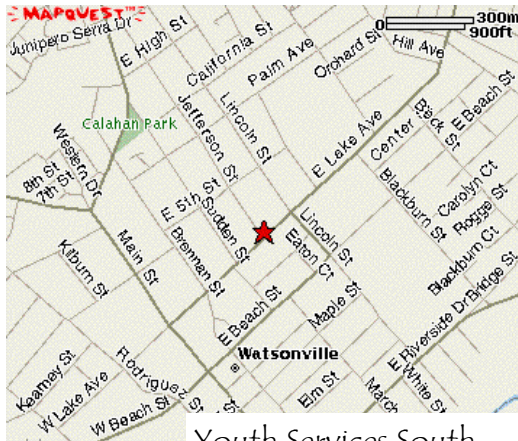

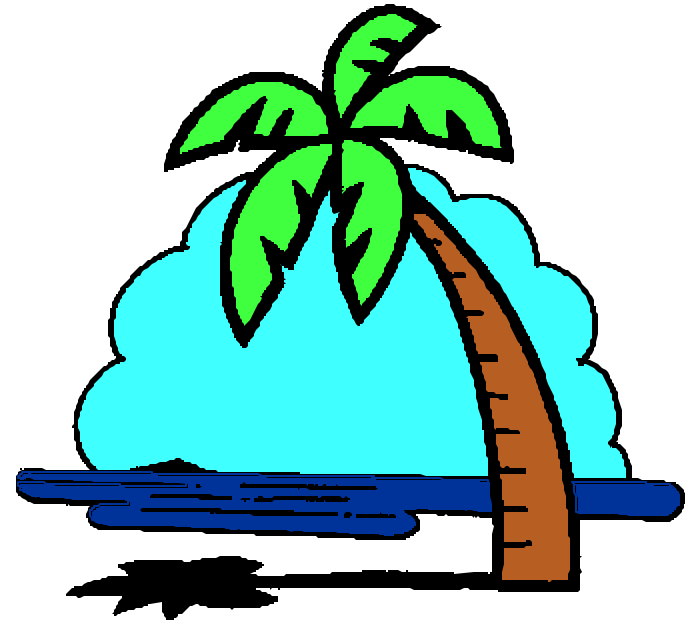

The Youth Services O.A.S.I.S. Program

O.A.S.I.S. (Outpatient Alternative with Supportive Intensive Services) is one of the numerous programs provided by Youth Services. The primary objective of the O.A.S.I.S Program is to provide intensive community-based wrap-around services to youth and families going through the court process. The program consists of individual and group counseling, parent support, diversionary activities, and judicial system education. Services are available in both English and Spanish. The O.A.S.I.S Program is designed to make certain that youth appear at their court hearings and do not re-offend between the time they are released into the community and the time they return to court for their disposition hearing.

Participants in the program are minors on the Home Supervision and Electronic Monitoring Programs. Each youth is assigned a counselor with whom s/he is involved to varying degrees of intensity. Depending on the individual case plan, the youth may be required by Probation to meet with his or her counselor anywhere from one to four times a week. The program can last from a few days to a couple months.

The Probation and the Youth Services staff meet once a week to discuss the progress of the youth on the program. O.A.S.I.S. staff is available to attend court with the youth and his or her family to provide support and feedback.
