PROBATION AGREEMENT AND ORDER

I AGREE TO THE FOLLOWING STANDARD CONDITIONS OF PROBATION:

- 1 _____ **Term of Probation:** A period not to exceed:
 1 year 2 years Up to the age of 21

- 2 _____ **General Behavior:** I will obey all local, state and federal laws.
- 3 _____ **Reporting:** I will contact my JPPO whenever he/she tells me to make contact.
- 4 _____ **Parents:** I will obey my parent/guardian/custodian. My parent/guardian/custodian will be working with my JPPO to help me complete probation.
- 5 _____ **Residence:** I will live at _____ during the period of my probation and under the custody of _____. Requests to stay somewhere else must be approved in advance by my parent/guardian/custodian and JPPO.
- 6 _____ **Education:** I will go to school or obtain my GED. My JPPO will help me find a school that will help me continue my education. My JPPO will see how I do in school and will help me if I am having trouble. My JPPO may agree to let me get a GED.
- 7 _____ **Weapons:** I will not possess any weapons or be around people who I know carry weapons.
- 8 _____ **Probation Orientation.** I will complete a probation orientation. If I have already attended an orientation I may not have to go.

9 _____ **Search and Seizure:** I will submit to a search of my person, property or residence by my JPPO, with pre-approval of the Chief Juvenile Probation Parole Officer if it is necessary for my safety or the safety of others.

I AGREE TO THE FOLLOWING SPECIAL CONDITIONS:

10 _____ **Associates:** I will not have any kind of contact with the following people: _____

11 _____ **Curfew:** I will obey the curfew set by my JPPO after my JPPO talks with me and my parent/guardian/custodian. This curfew can be changed by my JPPO during the term of my probation, but only after discussions with me and my parent/guardian/custodian.

12 _____ **Counseling:** I will attend and complete counseling and treatment. My JPPO will assist me in identifying counseling or treatment services that will help me during my probation.

13 _____ **Driving:** I will not drive if my driving privilege is restricted by the Court. I may drive with a valid driver's license, registration and insurance.

14 _____ **Alcohol/Drugs:** I will not use alcohol or illegal drugs. I will submit to alcohol/drug screenings. These screenings will be paid for by me unless otherwise ordered by the Court.

15 _____ **Restitution:** I will pay restitution as Court ordered. If restitution is ordered by the Court my JPPO will assist me in developing a payment schedule that is reasonable for me to pay. I will be given a copy of my restitution schedule. I may be required to participate in a Victim/Offender Mediation.

16 _____ **Community Service:** I will perform _____ hours of community service as Court ordered. After talking with me and my parent/guardian/custodian, my JPPO will develop this plan. Credit may be given to me for work, counseling, or other good deeds as identified by my JPPO.

17 _____ **Work:** I will get and keep a job. If appropriate, my JPPO will assist me in finding a job.
